- Artists may submit up to 2 pieces with no size restrictions. There is no entry fee to submit works to be juried.
- There is a \$20 Registration Fee for each accepted work; payable when work is delivered to the Art Center.
- All media is welcome including free-standing sculpture.
- Art will be reviewed by the Juror and notification of acceptance will be sent to the artist via email.
- All accepted work should be appropriately ready to hang or display.
- We ask that artists follow the **Timeline for Artists** and **Submission Process (right)** carefully.
- Individual Children’s Entries (age 12 and under) are welcome; please follow same entry process/ indicate that it is a Children’s Entry. Space for Children’s Entries will be limited. \$10 Reg. Fee upon delivery, after acceptance by the juror.

Prospectus:

“**The Reformation Remembered—Expressions of Faith**” is an art exhibit that will ask visual artists of all media to submit work that reflects inspiration in the Reformation.

Artistic expression could come from many aspects of this transformational event.

Creative considerations might include history, legacy, sacred music, faith, word, grace or Luther himself...just to name a few!
